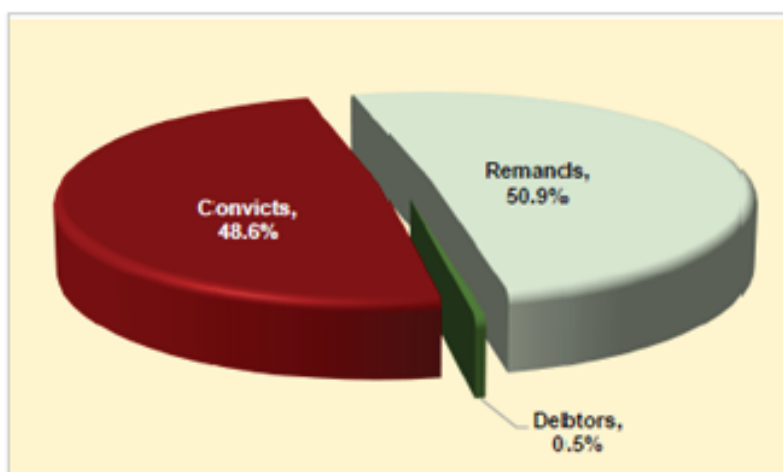


Figure 1: Composition of Prisons population.

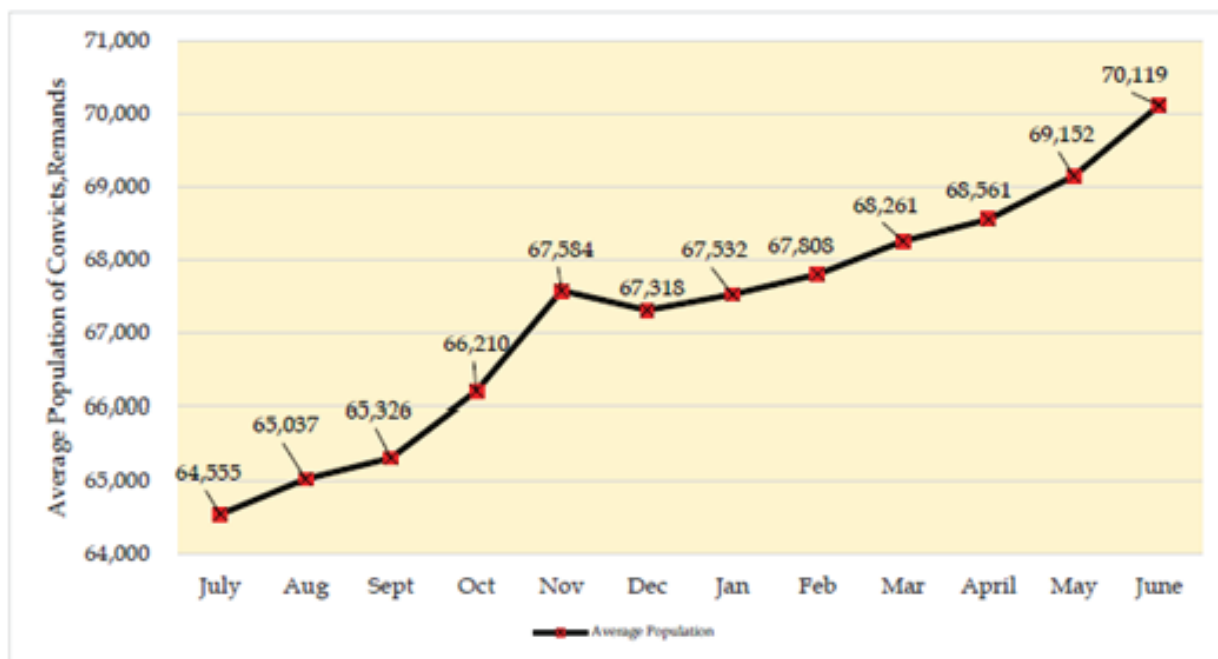


Figure 1: Monthly population Trend of prisoners

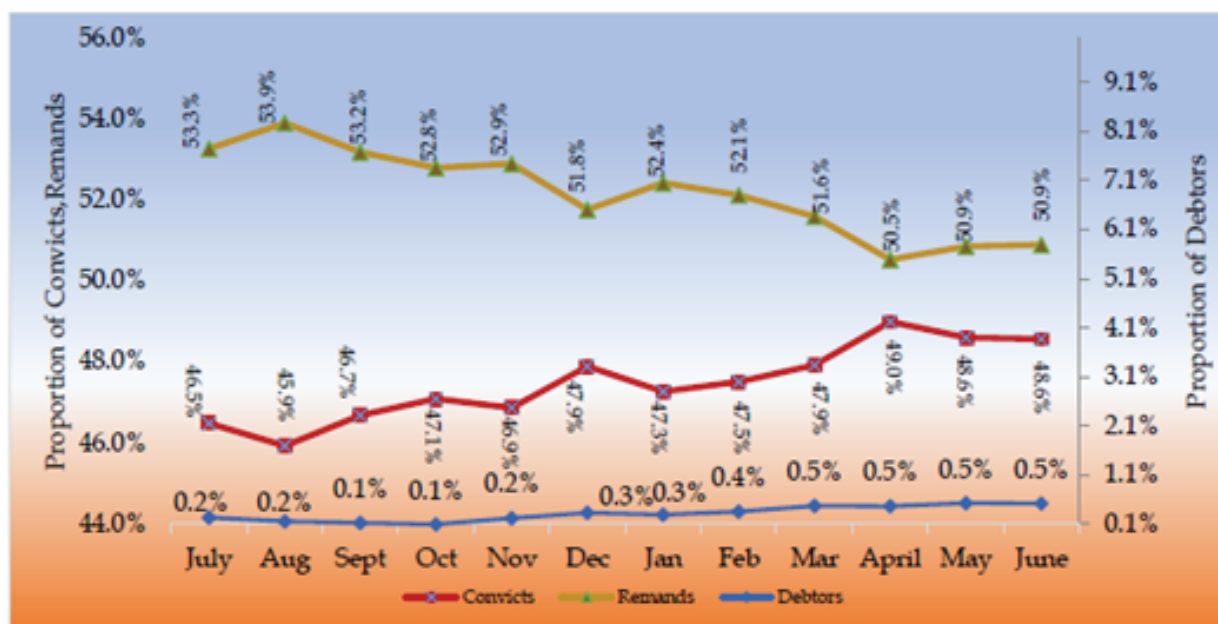


Figure 2: Monthly composition trends of convicts, remands, and debtors

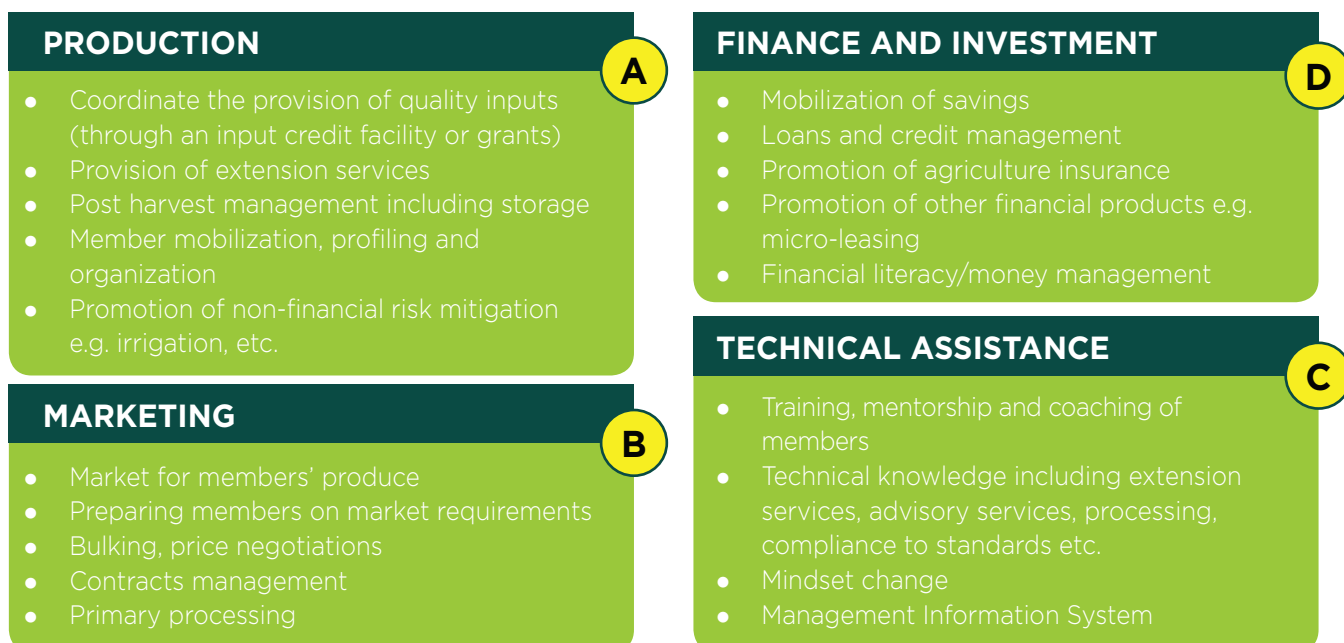

Key Functions of the PDM SACCO

PDM SACCO – MULTI PURPOSE SACCO

At Parish Level



Unpacking the Parish Revolving Fund

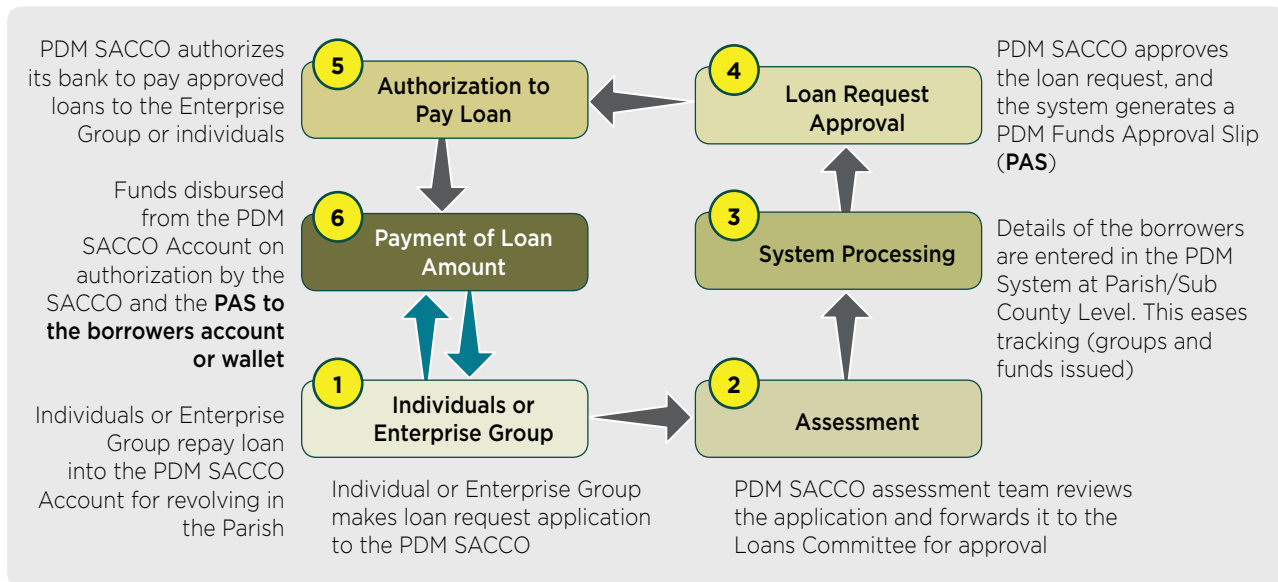
- A Parish Revolving Fund shall be established to enable subsistence households access cheap credit to create self-employment opportunities
- The PDM SACCO shall be responsible for the management of the Parish Revolving Fund (including but not limited to documentation/receipt of applications, loan appraisals, disbursements and recovery)
- The Parish Development Committee will determine the period within which the loan must be repaid back and the amount to be accessed by each group/ income generating activity. The maximum loan term shall not exceed 3 years (36 months) while the amount shall depend on the nature of activity being undertaken.
- Households/Enterprise Groups shall apply for loans from a PDM SACCO at an interest rate of 5% per annum
- The PDM SACCO shall approve loans and disburse funds to registered members
- The PDM SACCO shall follow-up repayments and manage the revolving of PRF funds within the Parish
- Enterprise Groups at a Parish shall access auxiliary services like quality inputs, business advisory services,

financial literacy, extension services, insurance and guaranteed markets through the PDM SACCO

h) The grace period will depend on the nature of the enterprise. It will be agreed upon mutually between

PDM SACCO members and the District on consideration of the project maturity and cash-flow projections

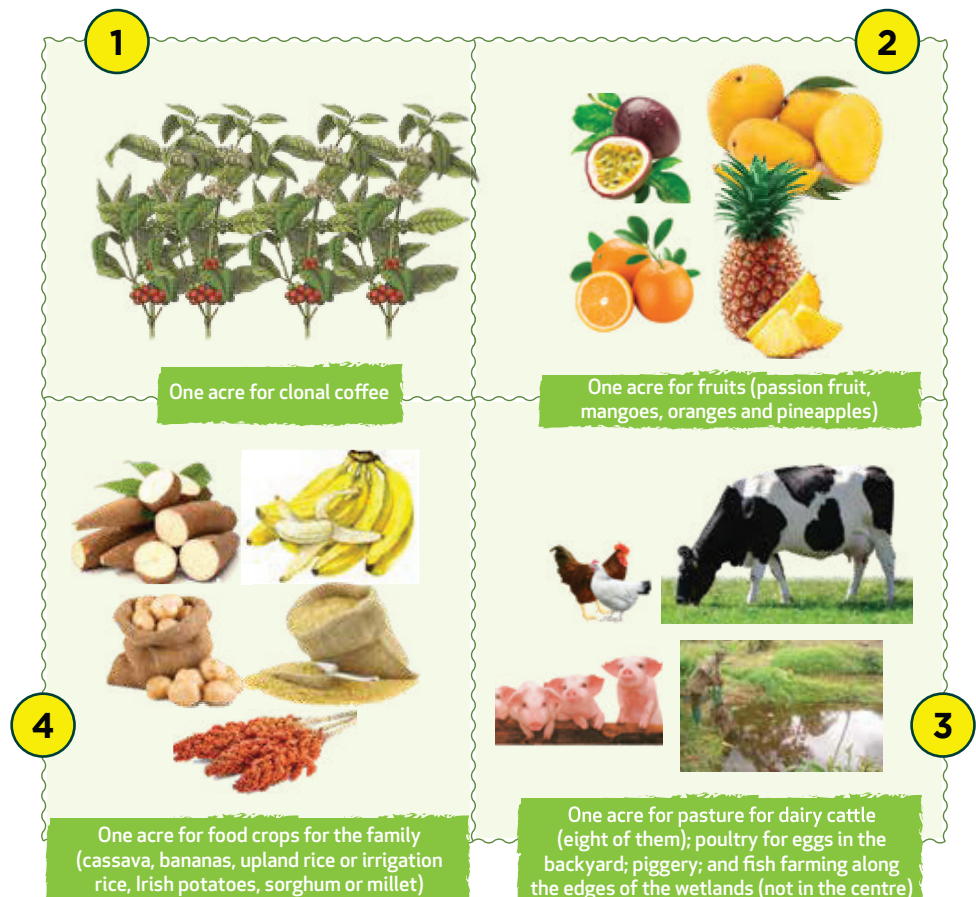
Loan approval and Repayment Process



Using the 4-acre model to enhance productivity

In choosing what enterprise to undertake, subsistence households are advised to take into consideration land as a factor of production.

For subsistence households with 4 acres, the "Four-acre model" will be adopted and applied as flows;

A total of 50 officers of Uganda Prisons Service attended Customer Care and Public Relations Training at Maria Flo Hotel in Masaka City.

The training was conducted by Mr. Frank Baine, Commissioner of Prisons (Corporate Affairs) on Saturday targeting Officers in Charge, Medical Officers, Social Workers and other Senior officers from the South Western Region of Uganda.

In his elaborate lecture on administration of Prisons, Mr. Baine implored officers in Charge to remain patriotic, professional, committed and dedicated to service adding that they remain the pillar of the Prison unit they are manning, he emphasized on the need to protect human rights at all times.

"As an OC, you ought to protect the image of the Uganda Prisons brand and its uniqueness, customer care is an important complement in management of prisoners, you have to be cautious and apply humane approach while implementing lawful orders

UPS AND JUSTICE DEFENDERS HOLD SENSITISATION OF INMATES ON THEIR LEGAL AND OTHER RIGHTS

Uganda Prisons Service on the 27th June 2022 held the legal education training of inmates at Murchison Bay Prison organized in partnership with Justice Defenders, a UK based Non-profit organization transforming the lives of prisoners in Africa.

The training was officially opened by Mr. Anatoli Biryomumisho, Assistant Commissioner in charge Formal and Vocational Education on behalf of the Commissioner General of Prisons and was facilitated by highly experienced legal officers from the Justice Defenders, scholars, law tutors and students of the Law Development Center.

In his address, Mr. Anatoli shared an experience of introducing the idea of inmate education in Uganda Prisons when he enrolled in back 1997, he commended Justice Defenders for attributes they

play in improving administration of justice in Uganda and encouraged the inmates to adopt various initiatives like plea bargaining, mediation processes, court room etiquette and case management systems among others.

Inmates were reminded that Plea bargaining has been introduced to help in achieving efficiency within the Criminal Justice System by;

- Promoting orderly and timely management of trials; facilitating amicable settlements in criminal matters;

- Mitigating case backlog;

- Reducing the workload on prison officials;

- Reducing prison congestion, and ;

- Quick relief from the anxiety of criminal prosecution, as the accused will be encouraged to own up criminal responsibility.

Plea-bargaining also promotes victim participation in the adjudication process.

Mr. Daniel Ssekijjo, Superintendent of Prisons

(Officer in Charge - Murchison Bay), made positive remarks about successfully opening a legal office at the Prison with support from Justice Defenders, he said training inmate/staff paralegals and lawyers within the Prison are ongoing to provide legal services for themselves and others. He emphasized continuous discipline, commitment and hard work of inmates.

Ms. Karen Siadi, Country Director - Justice Defenders said the organization aims at making justice and fair trial accessible to prisoners in Africa through legal education, training, and practice.

She added that they are training defenseless communities of prisoners and prison staff to become paralegals and lawyers, equipping them with legal skills and knowledge to assert their rights and provide legal services for themselves and others.

"To keep the wheels of justice turning in COVID-19, we have made our paralegal training available virtually, and we are linking prisons to courts so judges can hold virtual courts", she noted.
